Four Avenues of Service

1 Club Service focuses on strengthening fellowship and ensuring the effective functioning of the club.

2 Vocational Service encourages Rotarians to serve others through their vocations and to practice high ethical standards.

3 Community Service covers the projects and activities the club undertakes to improve life in its community.

4 International Service encompasses actions taken to expand Rotary's humanitarian reach around the globe and to promote world understanding and peace.

The Object of Rotary

To encourage and foster the ideal of service as a basis of worthy enterprise and, in particular to encourage and foster:

FIRST: The development of acquaintance as an opportunity for service;

SECOND: High ethical standards in business and professions, the recognition of the worthiness of all useful occupations, and the dignifying by each Rotarian of his/her occupation as an opportunity to serve society;

THIRD: The application of the ideal of service by every Rotarian to his personal, business and community life.

FOURTH: The advancement of international understanding, goodwill, and peace through a world fellowship of business and professional men and women united in the ideal of service.

Program:



Suzi deFosset was introduced by MATT P. Suzi graduated from Loyola Marymount University in 1996 with a Masters in Psychology, with an emphasis in substance abuse. She moved from the Bay Area 4 years ago to Auburn and started working with The Gathering Inn in Roseville as the Executive Director. Since then they have grown from 15 churches supporting them to 60. The Gathering Inn is becoming the social service organization for the homeless in Placer County.

Suzi runs the only full time shelter between Sacramento and Reno. They provide for up to 60 people per night. Occupants are admitted first come, first served for up to 60 people. They must be clean and sober, not on Megan's Law website, drug-free (tests are random), and have a current TB test.

There are 32 hosting churches throughout the County which provide evening meals and a place to sleep. There is a 10-week program for

overcoming substance abuse. Nationally 1/3 remain sober, another 1/3 are in and out, and 1/3 never recover. They are meeting the national average.

Retired Kaiser doctors staff the Saturday free medical clinic for non-chronic ailments. The case management team helps people become more self sufficient. They are funded solely by donations, grants and fundraisers, including a walk-run, which needs volunteers. Clubs like ours host dinners at the various churches.

Sacramento County is losing its emergency shelter for 200 people per night. Some preference is shown for women and children. Children go to school nearby. Church hosts provide games and clothes for children. A guest can stay up to 6 moths. Some people are without ID and Social Security card, which they help replace.

The annual budget is \$565,000; \$220k from grants, \$100k fundraisers, and the rest from donations. They accept donations of blue jeans and slightly used clothing, and toiletries. They do all their own laundry of bedding. Packages of underwear are needed. 17% more foster age youth were helped this summer than last. More people are helped during the summer than during the cold months. About 80% of their guests have mental health problems.
